

A PMI reading above 50 percent (red line below) indicates that the manufacturing economy is generally expanding and below 50 percent means it is contracting.





Commentary

Economic activity in the manufacturing sector contracted in March, while the overall economy grew for the 131st consecutive month. New Orders, Production, Employment, Backlog, Inventories, Prices and Exports & Imports contracted, and Supplier Deliveries slowed at a faster rate.

Industrial Production and Capacity Utilization

The Production Index (in red below) measures real output and is expressed as a percentage of real output in a base year, currently 2007. The Capacity Index (in green below), which is an estimate of sustainable potential output, is also expressed as a percentage of real output in 2007.

Commentary

In March, industrial production and manufacturing output fell by 5.4% and 6.3%, respectively, representing their largest decreases since January 1946 and February 1946, respectively. At 103.7% of its 2012 average, total industrial production was 5.5% lower in March than it was a year earlier, as the COVID-19 pandemic led many factories to suspend operations late in the month.

Unemployment Rate

Unemployment rate is traditionally defined as the percentage of the total labor force that is actively looking for gainful employment.





Commentary

In March, the unemployment rate rose by 0.9% to 4.4% and the number of unemployed persons rose by 1.4 million to 7.1 million. Total nonfarm payroll employment experienced a drop of 701,000, over 67% of which was attributable to declines in leisure & hospitality related to the effects of coronavirus (COVID-19) and efforts to contain it.

Producer Price Index (PPI) and Consumer Price Index (CPI)

The PPI measures the average change over time in prices received (price changes) by producers for domestically produced goods, services and construction. The CPI measures changes in the prices paid by urban consumers for a representative basket of goods and services.





Commentary

CPI for all items fell 0.4% in March, driven by sharp declines in in the gasoline, airline fares, lodging away from home and apparel indexes. PPI for final demand fell 0.2% in March, as the 1.0% decrease in the final demand goods index related to the 6.7% drop in energy prices more than offset the 0.2% increase in final demand services index related to increasing trade margins.

Last Three Years Daily from March 31, 2017 to March 31, 2020 Price as Percent of Base (March 31, 2017 = 0%)




Comparative Sector Index Performance (Last Twelve Months)

Comparative Subsector LTM EV/Revenue




Comparative Subsector LTM EV/EBTIDA


Comparative Subsector LTM Gross Margin

Comparative Subsector LTM EBITDA Margin





Huntington Ingalls Industries, Inc. (NYSE:HII) entered into an agreement to acquire Hydroid, Inc. from Kongsberg Maritime AS for approximately \$350 million on February 4, 2020. Hydroid is a leading provider of advanced marine robotics to the defense and maritime markets, and will become part of Huntington Ingalls Industries' Technical Solutions Unmanned Systems business unit. In conjunction with the transaction, Huntington Ingalls Industries and Kongsberg Maritime have established a strategic alliance to jointly market naval and maritime products and services to the U.S. government market and global markets.



Delphi Technologies	BorgWarner	\$3,294.6

BorgWarner Inc. (NYSE:BWA) entered into a definitive transaction agreement to acquire Delphi Technologies PLC (NYSE:DLPH) for \$1.5 billion on January 28, 2020, in a transaction valued at \$3.3 billion. Delphi Technologies engages in the design, development, and manufacture of integrated powertrain technologies worldwide. Delphi Technologies will become a wholly-owned subsidiary of BorgWarner Inc. Current BorgWarner stockholders are expected to own ~84% of the combined company, which will be led by Frédéric Lissalde, BorgWarner's President and CEO, and Kevin Nowlan, BorgWarner's CFO.



Traton SE (XTRA:8TRA) offered to acquire the remaining 83.2% stake in Navistar International Corporation (NYSE:NAV) for \$2.9 billion on January 30, 2020, in a transaction valued at \$8.1 billion. Under the terms of the offer, Traton will acquire Navistar shares at \$35 per share in cash. Volkswagen AG (XTRA:VOW3), parent of Traton, has signaled its intention to provide funds for financing. Navistar, through its subsidiaries, manufactures and sells commercial trucks, diesel engines, school and commercial buses and service parts for trucks and diesel engines worldwide. The transaction is expected to close by the end of 2020.


