

AMN Healthcare Services, Inc. (NYSE:AMN) reported net income of \$114.0 million for fiscal year 2019 as compared to \$141.7 million for the prior year. Earnings per share were \$2.40 versus \$2.91 for the prior year. Revenues for the year ncreased to \$2,222.1 million from \$2,136.1 million for fiscal year 2018.

ASGN Incorporated (NYSE:ASGN) reported net income of \$174.7 million for fiscal year 2019 as compared to \$157.7 million for the prior year. Earnings per share were \$3.28 versus \$2.97 for the prior year. Revenues for the year increased to \$3,923.9 million from \$3,399.8 million for fiscal year 2018.

Barrett Business Services, Inc. (NasdaqGS:BBSI) reported net income of \$48.3 million for fiscal year 2019 as compared to \$38.1 million for the prior year. Earnings per share were \$6.27 versus \$4.98 for the prior year. Revenues for the year increased to \$942.3 million from \$940.7 million for fiscal year 2018.

CBIZ, Inc. (NYSE:CBZ) reported net income of \$70.7 million for fiscal year 2019 as compared to \$61.6 million for the prior year. Earnings per share were \$1.26 versus \$1.09 for the prior year. Revenues for the year increased to \$948.4 million from \$922.0 million for fiscal year 2018.

Computer Task Group, Incorporated (NasdaqGS:CTG) reported net income of \$4.1 million for fiscal year 2019 as compared to (\$2.8) million for the prior year. Earnings per share were \$0.29 versus (\$0.20) for the prior year. Revenues for the year increased to \$394.2 million from \$358.8 million for fiscal year 2018.

CRA International, Inc. (NasdaqGS:CRAI) reported net income of \$20.7 million for fiscal year 2019 as compared to \$22.5 million for the prior year. Earnings per share were \$2.53 versus \$2.61 for the prior year. Revenues for the year increased to \$451.4 million from \$417.6 million for fiscal year 2018.

CRA International, Inc. Earnings per share were \$5.69 versus \$3.93 for the prior year. Revenues for the year increased to \$2,352.7 million from \$2,027.9 million for fiscal year 2018.

Heidrick & Struggles International, Inc. (NasdaqGS:HSII) reported net income of \$46.9 million for fiscal year 2019 as compared to \$49.3 million for the prior year. 


