



#### **Selected News**

**AMN Healthcare Services, Inc. (NYSE:AMN)** reported third quarter net income of \$26.1 million for fiscal year 2020 as compared to \$23.5 million for the prior year period. Earnings per share were \$0.55 versus \$0.49 for the prior year period. Revenues for the quarter decreased to \$551.6 million from \$567.6 million for the same period in fiscal year 2019.

**Cross Country Healthcare, Inc. (NasdaqGS:CCRN)** reported third quarter net income of (\$1.3) million for fiscal year 2020 as compared to (\$3.1) million for the prior year period. Earnings per share were (\$0.04) versus (\$0.09) for the prior year period. Revenues for the guarter decreased to \$194.0 million from \$209.2 million for the same period in fiscal year 2019.

**Barrett Business Services, Inc. (NasdaqGS:BBSI)** reported third quarter net income of \$18.5 million for fiscal year 2020 as compared to \$25.0 million for the prior year period. Earnings per share were \$2.40 versus \$3.24 for the prior year period. Revenues for the quarter decreased to \$227.5 million from \$248.0 million for the same period in fiscal year 2019.

**Hudson Global, Inc. (NasdaqGS:HSON)** reported third quarter net income of (\$1.2) million for fiscal year 2020 as compared to \$0.4 million for the prior year period. Earnings per share were (\$0.40) versus \$0.12 for the prior year period. Revenues for the quarter decreased to \$25.4 million from \$25.8 million for the same period in fiscal year 2019.

**Fair Isaac Corporation (NYSE:FICO)** reported net income of \$236.4 million for fiscal year 2020 as compared to \$192.1 million for the prior year. Earnings per share were \$7.90 versus \$6.34 for the prior year. Revenues for the year increased to \$1,294.6 million from \$1,160.1 million for fiscal year 2019.

**Korn Ferry (NYSE:KFY)** reported second quarter net income of \$27.8 million for fiscal year 2021 as compared to \$42.8 million for the prior year period. Earnings per share were \$0.51 versus \$0.77 for the prior year period. Revenues for the quarter decreased to \$435.4 million from \$492.4 million for the same period in fiscal year 2020.

**Huron Consulting Group Inc. (NasdaqGS:HURN)** reported third quarter net income of \$11.1 million for fiscal year 2020 as compared to \$13.7 million for the prior year period. Earnings per share were \$0.50 versus \$0.61 for the prior year period. Revenues for the quarter decreased to \$205.3 million from \$219.3 million for the same period in fiscal year 2019.

**Insperity, Inc. (NYSE:NSP)** reported third quarter net income of \$20.0 million for fiscal year 2020 as compared to \$25.9 million for the prior year period. Earnings per share were \$0.51 versus \$0.63 for the prior year period. Revenues for the quarter decreased to \$1,007.8 million from \$1,043.4 million for the same period in fiscal year 2019.

**Kelly Services, Inc. (NasdaqGS:KELY.A)** reported third quarter net income of \$16.7 million for fiscal year 2020 as compared to (\$10.5) million for the prior year period. Earnings per share were \$0.42 versus (\$0.27) for the prior year period. Revenues for the quarter decreased to \$1,038.2 million from \$1,267.7 million for the same period in fiscal year 2019.

**Kforce Inc. (NasdaqGS:KFRC)** reported third quarter net income of \$18.8 million for fiscal year 2020 as compared to \$14.9 million for the prior year period. Earnings per share were \$0.89 versus \$0.64 for the prior year period. Revenues for the quarter increased to \$365.4 million from \$345.6 million for the same period in fiscal year 2019.

**RCM Technologies, Inc. (NasdaqGM:RCMT)** reported third quarter net income of (\$0.2) million for fiscal year 2020 as compared to \$0.3 million for the prior year period. Earnings per share were (\$0.02) versus \$0.03 for the prior year period. Revenues for the guarter decreased to \$31.6 million from \$40.3 million for the same period in fiscal year 2019.





#### **Selected News**

Casella Waste Systems, Inc. (NasdaqGS:CWST) reported third quarter net income of \$15.1 million for fiscal year 2020 as compared to \$12.4 million for the prior year period. Earnings per share were \$0.31 versus \$0.26 for the prior year period. Revenues for the guarter increased to \$202.7 million from \$198.5 million for the same period in fiscal year 2019.

**Chemed Corporation (NYSE:CHE)** reported third quarter net income of \$67.7 million for fiscal year 2020 as compared to \$58.9 million for the prior year period. Earnings per share were \$4.14 versus \$3.56 for the prior year period. Revenues for the quarter increased to \$528.3 million from \$480.6 million for the same period in fiscal year 2019.

**Colliers International Group Inc. (TSX:CIGI)** reported third quarter net income of \$21.2 million for fiscal year 2020 as compared to \$29.6 million for the prior year period. Earnings per share were \$0.52 versus \$0.74 for the prior year period. Revenues for the quarter decreased to \$692.3 million from \$736.9 million for the same period in fiscal year 2019.

**Comfort Systems USA, Inc. (NYSE:FIX)** reported third quarter net income of \$50.1 million for fiscal year 2020 as compared to \$36.2 million for the prior year period. Earnings per share were \$1.36 versus \$0.98 for the prior year period. Revenues for the quarter increased to \$714.1 million from \$706.9 million for the same period in fiscal year 2019.

**EMCOR Group, Inc. (NYSE:EME)** reported third quarter net income of \$61.2 million for fiscal year 2020 as compared to \$81.8 million for the prior year period. Earnings per share were \$1.11 versus \$1.45 for the prior year period. Revenues for the quarter decreased to \$2,201.7 million from \$2,287.7 million for the same period in fiscal year 2019.

**Healthcare Services Group, Inc. (NasdaqGS:HCSG)** reported third quarter net income of \$27.6 million for fiscal year 2020 as compared to \$18.3 million for the prior year period. Earnings per share were \$0.37 versus \$0.25 for the prior year period. Revenues for the quarter decreased to \$435.9 million from \$455.6 million for the same period in fiscal year 2019.

Heritage-Crystal Clean, Inc (NasdaqGS:HCCI) reported third quarter net income of \$4.0 million for fiscal year 2020 as compared to \$6.0 million for the prior year period. Earnings per share were \$0.17 versus \$0.25 for the prior year period. Revenues for the guarter decreased to \$87.1 million from \$104.8 million for the same period in fiscal year 2019.

**Rollins, Inc. (NYSE:ROL)** reported third quarter net income of \$79.6 million for fiscal year 2020 as compared to \$44.1 million for the prior year period. Earnings per share were \$0.24 versus \$0.13 for the prior year period. Revenues for the quarter increased to \$583.7 million from \$556.5 million for the same period in fiscal year 2019.

**Sodexo S.A. (ENXTPA:SW)** reported net income of (\$376.6) million for fiscal year 2020 as compared to \$731.4 million for the prior year. Earnings per share were (\$2.58) versus \$4.95 for the prior year. Revenues for the year decreased to \$23,097.4 million from \$24,146.5 million for fiscal year 2019.

**The Brink's Company (NYSE:BCO)** reported third quarter net income of (\$23.9) million for fiscal year 2020 as compared to \$5.4 million for the prior year period. Earnings per share were (\$0.47) versus \$0.10 for the prior year period. Revenues for the quarter increased to \$970.5 million from \$928.4 million for the same period in fiscal year 2019.

**UniFirst Corporation (NYSE:UNF)** reported net income of \$135.8 million for fiscal year 2020 as compared to \$179.1 million for the prior year.
