





Selected News

Korn Ferry (NYSE:KFY) reported net income of \$114.5 million for fiscal year 2021 as compared to \$104.9 million for the prior year. Earnings per share were \$2.09 versus \$1.90 for the prior year. Revenues for the year decreased to \$1,810.0 million from \$1,932.7 million for fiscal year 2020.

Paychex, Inc. (NasdaqGS:PAYX) reported net income of \$1,097.5 million for fiscal year 2021 as compared to \$1,098.1 million for the prior year. Earnings per share were \$3.03 versus \$3.04 for the prior year. Revenues for the year increased to \$4,056.8 million from \$4,040.5 million for fiscal year 2020.





Selected News

ABM Industries Incorporated (NYSE:ABM) reported second quarter net income of \$31.1 million for fiscal year 2021 as compared to (\$136.8) million for the prior year period. Earnings per share were \$0.46 versus (\$2.05) for the prior year period. Revenues for the quarter increased to \$1,497.4 million from \$1,496.0 million for the same period in fiscal year 2020.

UniFirst Corporation (NYSE:UNF) reported third quarter net income of \$42.0 million for fiscal year 2021 as compared to \$21.3 million for the prior year period. Earnings per share were \$2.21 versus \$1.12 for the prior year period. Revenues for the quarter increased to \$464.3 million from \$445.5 million for the same period in fiscal year 2020.
