A PMI reading above 50% (red line below) indicates that the manufacturing economy is generally expanding and below 50% means it is contracting.





Commentary

Purchasing activity in the manufacturing sector decreased in September, while the overall economy achieved a 28th consecutive month of growth. Production and Imports grew in September 2022, while New Orders, Backlog, New Exports, Suppliers Deliveries all slowed down at an accelerated rate.

Unemployment rate is traditionally defined as the percentage of the total labor force that is actively looking for gainful employment.





Commentary

The unemployment rate slightly decreased to 3.5% in September, and the number of unemployed persons increased to 5.8 million. Notable job gains occurred in leisure & hospitality.

Industrial Production and Capacity Utilization

The Production Index (in red below) measures real output and is expressed as a percentage of real output in a base year, currently 2017. The Capacity Index (in green below), which is an estimate of sustainable potential output, is also expressed as a percentage of real output in 2017.



Commentary

Industrial production grew by 0.4% in September. Manufacturing output rose 0.4% after advancing at a similar pace the previous month. At 105% of its 2017 average, total industrial production in September was 5.3% above its year-earlier level. Capacity utilization also increase by 0.2% in September.

Producer Price Index and Consumer Price Index.

The PPI measures the average change over time in prices received (price changes) by producers for domestically produced goods, services and construction. The CPI measures changes in the prices paid by urban consumers for a representative basket of goods and services.





Commentary

The Consumer Price Index for All Urban Consumers increased by 0.4% in September 2022. Consumer prices for all items less food and energy rose 6.6 percent over the past 12 months, the largest 12-month increase since August 1982. The Producer Price Index for final demand increased 0.4% in September, final demand prices declined 0.2% in August and 0.4% in July.


Comparative Sector Index Performance (Last Twelve Months)

Comparative Subsector LTM EV/Revenue



Commentary

During the last twelve months, our subsector indices had a mean EV/Revenue of 1.6x (i.e., red line) and a median of 1.4x (i.e., yellow line). Of the subsectors, Semiconductor Capital Equipment and Electrical equipment shared the high multiple at 3.0x and Industrial Recycling had the low multiple at 0.6x.

Comparative Subsector LTM EV/EBTIDA



Comparative Subsector LTM Gross Margin



Comparative Subsector LTM EBITDA Margin




Index Subsector LTM EV/EBITDA vs. EBITDA Margin*








