

AMN Healthcare Services, Inc. (NYSE:AMN) reported first quarter net income of \$17.3 million for fiscal year 2024 as compared to \$84.1 million for the prior year period. Earnings per share were \$0.45 versus \$2.02 for the prior year period. Revenues for the quarter decreased to \$820.9 million from \$1,126.2 million for the same period in fiscal year 2023.

Cross Country Healthcare, Inc. (NasdaqGS:CCRN) reported first quarter net income of \$2.7 million for fiscal year 2024 as compared to \$29.4 million for the prior year period. Earnings per share were \$0.08 versus \$0.81 for the prior year period. Revenues for the quarter decreased to \$379.2 million from \$622.7 million for the same period in fiscal year 2023.

Barrett Business Services, Inc. (NasdaqGS:BBSI) reported first quarter net income of (\$0.1) million for fiscal year 2024 as compared to \$0.8 million for the prior year period. Earnings per share were (\$0.02) versus \$0.12 for the prior year period. Revenues for the quarter increased to \$265.8 million from \$254.7 million for the same period in fiscal year 2023.





Aramark (NYSE:ARMK) reported second quarter net income of \$53.4 million for fiscal year 2024 as compared to \$56.0 million for the prior year period. Earnings per share were \$0.20 versus \$0.21 for the prior year period. Revenues for the quarter increased to \$4,199.9 million from \$3,916.2 million for the same period in fiscal year 2023.

Clean Harbors, Inc. (NYSE:CLH) reported first quarter net income of \$69.8 million for fiscal year 2024 as compared to \$72.4 million for the prior year period. Earnings per share were \$1.29 versus \$1.33 for the prior year period. Revenues for the quarter increased to \$1,376.7 million from \$1,307.4 million for the same period in fiscal year 2023.

Colliers International Group Inc. (TSX:CIGI) reported first quarter net income of \$12.7 million for fiscal year 2024 as compared to (\$20.2) million for the prior year period. Compass Group PLC (LSE:CPG) reported second quarter net income of \$430.5 million for fiscal year 2024 as compared to \$380.0 million for the prior year period. Earnings per share were \$0.25 versus \$0.22 for the prior year period. Revenues for the quarter increased to \$10,372.0 million from \$9,327.5 million for the same period in fiscal year 2023.

The Brink's Company (NYSE:BCO) reported first quarter net income of \$49.3 million for fiscal year 2024 as compared to \$15.0 million for the prior year period. Earnings per share were \$1.09 versus \$0.31 for the prior year period. Revenues for the quarter increased to \$1,236.1 million from \$1,185.4 million for the same period in fiscal year 2023.

The GEO Group, Inc. (NYSE:GEO) reported first quarter net income of \$22.7 million for fiscal year 2024 as compared to \$28.0 million for the prior year period. Earnings per share were \$0.14 versus \$0.19 for the prior year period. Revenues for the quarter decreased to \$605.7 million from \$608.2 million for the same period in fiscal year 2023.
